One of this year's judges will be Michelle Dunn Marsh, from Aperture. This year there will be two categories:

STUDENT COMPETITION

- **First Prize:** \$1000
- **Second Prize:** \$500
- 10 Honorable Mention Awards

MASTER PRINTER COMPETITION

- **First Prize:** \$3000 (PLUS a Santa Fe Photographic Workshop session)
- **Second Prize:** \$2000
- 10 Honorable Mention Awards

Please note camera format with each entry. Selected large format images (4x5 and above) will be published in an upcoming issue of *View Camera* magazine.

ENTRY FEES

- \$35 for three images (additional images may be submitted at \$10 per image). Order ZSSM0263.
- Students may enter three images for \$15 (\$5 each per additional image). Order ZSSM0264. Copy of student I.D. required with entry.
- Return postage must be included with all entries.

PRINT REQUIREMENTS

- Prints no larger than 20 x 24" (mounted or unmounted). Name and title or identifying labels must be attached to the back, upper left-hand corner of each submission.

DUE DATE

- Entries must be received no later than March 16, 2007. Any entries received after this date will not be considered.

RETURN OF WORK

We will return your prints in the packaging you provide. Entries will be shipped by May 1.

LIABILITY

We will make every effort to protect your submissions and handle all entries with utmost care. Calumet Photographic and Ilford Photo are not responsible for damage, loss or replacement. Artists who desire to insure their work must make their own arrangements. If you insure the return of your work, include the entire completed insurance form. It must be stamped at the returning post office to be valid. Calumet and Ilford reserve the right to reproduce accepted work for contest promotion in both printed and electronic forms. Artists retain all other rights. Please pack your submissions carefully.
